



TAX INCENTIVES TO HELP YOUR HIRE AND RETAIN TALENT

The [Work Opportunity Tax Credit](#) gives your business the opportunity to earn a federal tax credit between \$1200 and \$9600 per employee. This tax credit is dependent upon the new employee qualifying as a member of one of the following target groups and working a minimum of 120 hours in their first year.

The target groups include:

- Qualified Short-Term Temporary Assistance to Needy Families or TANF Recipients
- Qualified Veterans
- Qualified Ex-Felons
- Qualified Vocational Rehabilitation Referred Individuals
- Qualified Supplemental Nutrition Assistance Program or SNAP Recipients
- Qualified Supplemental Security Income Recipients or SSI
- Qualified Long-term Unemployment Recipients
